GNA FUTBOL CLUB PLAYER AND PARENT CONTRACT

Congratulations on being selected to join **GNA FUTBOL CLUB** for the 2009-2010 Seasonal Year! Our coaches and Board of Directors hope that this will be an enjoyable year for you and your family. As part of the registration process, we want to insure that you are fully aware and understand the commitments **GNA FUTBOL CLUB** makes to you, and what our expectations and obligations from you as a result of your accepting the position offered to you. Please sign and date below acknowledging your understanding of the mutual expectations between you and **GNA FUTBOL CLUB**.

- ▶ Although it is our intent to honor the commitment to play with **GNA FUTBOL CLUB** for the entire seasonal year, we understand that accepting the position offered and completing the registration documents obligates me to pay the full registration fees, regardless of whether we later decide to leave **GNA FUTBOL CLUB** prior to the end of the seasonal year.
- ▶ We agree to make all installments toward fulfilling our financial obligation before or by the due dates, unless we apply to the Board of Directors for and receive written approval for a modified payment structure:
- ▶ We understand that **GNA FUTBOL CLUB** will provide training and coaching; opportunities to participate in league and tournament games; and a uniform and equipment package if needed.
- ▶ We understand that since this is a premier competitive environment, there is NO guarantee of minimum playing time.
- ▶ We understand that all funds collected will be credited to my child's team account to be used for such team expenses. These funds remain with **GNA FUTBOL CLUB** should the player decide to leave the club.
- ▶ Should the player wish to be released (other than for season ending injury or a move out of state) or to transfer to another club prior to the end of the seasonal year, the player/parents will be required to fulfill all financial obligations noted above before the Change of Status is processed. While no release will be granted to player until s/he and her/his family have met their financial obligations to **GNA FUTBOL CLUB**, the release of player once financial obligations have been brought "current" does not terminate the financial obligations of player and his family as set out herein unless otherwise agreed to in writing.
- ▶ We understand that failure to fulfill our financial obligations to **GNA FUTBOL CLUB** may result in the player being placed "Not in Good Standing" with the **GNA FUTBOL CLUB** which will result in the player's playing privileges being suspended until the obligations are fulfilled. This will also impact the player's ability to register with **GNA FUTBOL CLUB** next year.
- ▶ We have received and read the **GNA FUTBOL CLUB** Code of Ethics as printed below, and agree to abide by the requirements. We will act in a manner of respect at all practices, games, travel, etc, and serve as role models to others to maintain the integrity of ourselves, our team, and all of **GNA FUTBOL CLUB**. Players will conduct themselves in accordance with **GNA FUTBOL CLUB**, MOSSL, OSYSA, USYSA, USSF, and FIFA rules at all times, or will be subject to disciplinary action.

GNA FUTBOL CLUB CODE OF ETHICS

PLAYERS:

- I will encourage good sportsmanship from fellow players, coaches, officials and parents at all times.
- I will always remember that soccer is an opportunity to learn and have fun.
- I deserve to play in an environment that is free of drugs, tobacco and alcohol: and expect everyone to refrain from their use at all soccer training and games.
- I will do the best I can each day, remembering that all players have talents and weaknesses the same as I do.
- I will treat my coaches, other players and coaches, game officials, other administrators, and fans with respect at all times; regardless of race, sex, creed or abilities and I will expect to be treated accordingly.
- I will concentrate on playing soccer, always giving my best effort.
- I will play by the rules at all times.
- I will at all times control my temper, resisting the temptation to retaliate.
- My conduct during competition towards play of the game and all officials shall be in accordance with appropriate behavior, and in accordance with FIFA'S Laws of The Game, and in adherence to MOSSL rules.
- While traveling, I will conduct myself so as to be a credit to myself, and my team.
- A player cannot be cut from a team after he/she is registered to that team, unless he/she has exhibited conduct requiring dismissal, without prior consent from the Board of Directors. If requested by the player and/or parent, a hearing must be held for any involuntary player release.
- **Alcohol, illegal drugs, tobacco products and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during or after any game or at any time at the field and/or game complex.**

PARENTS/SPECTATORS:

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, game officials, and administrators at all times.
- I will place the emotional and physical well being of all players ahead of any personal desire to win.
- I will support the coaches, officials, and administrators working with my child, in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the players, not for the adults.
- I will ask my child to treat other players, coaches, game officials, administrators, and fans with respect.
- I will always be positive.
- I will always allow the coach to be the only coach, by refraining from coaching from the sidelines.
- I will not enter into arguments with the other team's parents, players, or coaches.
- I will not enter the field of play for any reason during the game.
- I will not criticize game officials.
- **Alcohol, illegal drugs, tobacco products and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during, after the game or at any other time at the field and/or game complex.**

Failure to comply may result in the suspension of your privilege to participate in **GNA FUTBOL CLUB** sanctioned events.
